

## **Multi-Market Thomas Rhett Today Show Trip Official Contest Rules**

These rules apply to the “Multi-Market Thomas Rhett Today Show Trip” Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WSOC-FM, WKXC-FM, WKLB-FM, WKML-FM, KCYE-FM, WXTU-FM, and WQYK-FM (each a “Station”). **In addition, the General Contest Rules posted at [www.country1037fm.com](http://www.country1037fm.com), [www.kicks99.com](http://www.kicks99.com), [www.country1025.com](http://www.country1025.com), [www.wkml.com](http://www.wkml.com), [www.1027thecoyote.com](http://www.1027thecoyote.com), [www.925xtu.com](http://www.925xtu.com) or [www.995qyk.com](http://www.995qyk.com) apply to this Contest. ### **1. HOW TO ENTER**

- a. The Contest will begin on Monday, May 6, 2019 and end on Thursday, May 16, 2019.
- b. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) winner selected in this multi-market Contest.

### **2. ELIGIBILITY RESTRICTIONS**

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North Carolina, South Carolina; Columbia, Richmond, Burke, McDuffie, Glascock, Hancock, Jefferson, Jenkins, Taliaferro, Warren, Washington, Wilkes, and Lincoln Counties, GA; Massachusetts, Rhode Island, New Hampshire; Clark County, NV; Pennsylvania, New Jersey, Delaware; Florida, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

### 3. PRIZES

- a. Up to one (1) Prize will be awarded in the Contest. Prize is being provided by The Valory Music Company and consists of one (1) trip for two (2) to New York, NY to see Thomas Rhett perform on The Today Show on Friday, May 31, 2019. Trip is being provided by The Valory Music Company and includes: roundtrip coach airfare for two (2) departing from an airport in the winner's area to a New York, NY area airport; two (2) nights standard hotel accommodations (standard room, double occupancy) at TBD New York, NY hotel; and two (2) VIP area tickets to Today Show on Friday, May 31, 2019; and VIP Meet and Greet Passes Thomas Rhett (meet and greet subject to artist availability). Trip dates are Thursday, May 30, 2019- Saturday, June 1, 2019. Approximate Retail Value of the Prize is \$3,500.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. - b. Prizes or prize certificates must be claimed at the office of the winner's local Station, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within five (5) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

- b. Odds of winning depend on the number of eligible online entries received during the Online Entry Period.
- c. Entrants need not listen to the Station or be present to win.
- d. Prize winner must confirm acceptance of prize within two (2) days of winning, or risk disqualification and selection of an alternate Prize winner (time permitting) in a random drawing of all remaining eligible online entries received.
